In an effort to standardize procedures regarding the Targeted Job Program, please review the guidelines listed below. Also enclosed is the current Target Program Request Form for your use.

GUIDELINES FOR TARGET PROGRAM

- 1.) Target Request Forms must be completed and returned to the Business Manager no later than 24 hours before the bid date. (Late requests will not be considered.)
- 2.) Target Request Forms must be completed and returned to receive consideration. (For example: If you request target money for a project and another signatory contractor bidding the same project fails to apply, only you will be considered. We simply do not have time to track and find who is bidding all projects.)
- 3.) Target Program Requests will only be considered if there are non-union contractors bidding the project.
