

## BENEFIT INFORMATION CHECKLIST

*Please note: Local 441 is available to assist you. Please contact us at (316) 265-4291 with any questions. This is a list of the possible benefits you may be entitled to. It provides you with basic information such as the amount (if known) as well as the contact's name and phone number for each entity associated with the Union. Again, our office has already reached out to BMGI (Health & Welfare/Local Pension/401(K) KSR office), the United Association, and National Pension to notify them.*

- ☐ **Local 441 Death Benefit - \$4,500.00** Available to all active Local 441 members participating in the death assessment program. This benefit check is enclosed as it is issued immediately upon notification of a member's death.
- ☐ **United Association (UA) Burial Benefit - \$2,500.00** Available for all active UA Members (this is processed **after** the certified death certificate and the other requested documents are received.)
- ☐ **National Pension – \$Unknown**; The National Pension Office has 30 days from the date of notification to send information regarding any benefits owed to the beneficiary and what their office will need in order to process the benefit. This notice will be sent as an envelope or packet via standard mail. Please note they will request a certified copy of the death certificate, but we will provide that to them when we receive it at our offices, so you do not need to send a duplicate.

- ☐ **Health & Welfare Benefit – \$15,000** - As long the member was still an active participant in the Health and Welfare Insurance Plan; (there may also be an additional \$15,000 of Accidental Death and Dismemberment if the death is a result of an auto accident as well as another additional \$5,000 if the member was wearing a seat belt.)

- ☐ **Local Pension Benefit – \$Unknown**; If there is a benefit owed, BMGI will send a packet to the beneficiary they have on file, along with a breakdown of the required information needed.

- ☐ **Mid-American Credit Union (MACU) - \$1,000.00**; If the member has an active Vacation Savings Account with MACU – this is an Accidental Death and Dismemberment benefit for all members of the credit union.
